**NOTIFICATION**

The Board of Management in its 222<sup>nd</sup> meeting held on 20-06-2018 ( Item No.12) has approved the proposal regarding *Modus Operandii* for implementation of Anti-plagiarism Software for Doctoral thesis of both Faculty of Agriculture, and Agricultural Engineering at the University level. The details of *Modus Operandii* for Anti-plagiarism are given as under :-

- The University must obtain the Software proposed by IAUA for implementation of Anti-plagiarism.
- In the first year it shall be operated on pilot mode.
- It shall be installed in the central library of the University.
- One person shall be made in-charge of the anti-plagiarism cell.
- Before submission of thesis scholar shall obtain the certificate on anti-plagiarism by running the thesis on approved software in the Central Library.
- Certificate shall be incorporate with the thesis submitted for evaluation in the Directorate of Instruction.
- The maximum limit for similarity index shall be proposed limit by UGC i.e., 30 percent.
- Maximum two attempts shall be given to the scholar to achieve the required similarity index.
- The proforma on required certificate finalized by the committee are attached.
- The research papers to be published from Doctoral thesis must get anti-plagiarism certificate prior to submission of manuscript to journal.

The format for issue of certificate on plagiarism check is enclosed herewith as **Annexure-I.**

The above decision of the Board may be brought to the notice of all the concerned.
