

ORDER

In supersession of the order No. P & D/5-3/287-A/99-2000 dated 17.1.2002, the administration of various funds known as students Fund shall now be as under:-

(A) Fee to be retained by the Colleges for its utilization:

- (a) Caution Money (College, Hostel, Mess & Libarary) deposited by the students for current year only. The balance up to 31st March of the preceeding year(s) may be remitted to the V.V.
- (b) Krishi Vishwa Magazine & College Magazine.
- (c) Student aid fund.
- (d) Athletio & Cultural fee.
- (e) Hostel Amalgamation and College amalgamation.

(B) Fee to be remitted to the Vishwa Vidyalaya:

- (a) Enrolment Fee.
- (b) Cution fee including registration fee.
- (c) Examination fee.
- (d) Laboratory fee.
- (e) Library fee.
- (f) Games & Sports fee.
- (g) Electrical charges, hostel fee(Room rent).
- (h) Payment seat Fee.
- (i) Identity Card Fee.

The entire receipts accumulated in connection with students fee till 31.3.2002, as classified at (B) above, may be remitted to the V.V. without fail. The fee etc. received from 1.4.2002 onwards may be remitted to the V.V. on the 10th day of each month regularly. As regards requirement of funds to run the College/Maintenance of hostel and all expenses in connection with students activities, a proper proposal with justification should be submitted to the V.V. well in advance for its inclusion in the Budget for the respective financial years,

so that the funds may be released on demand. No part and portion of the student fee earned by the respective Colleges should be utilised directly at College level, except the fee to be retained by the college as specified at A (a to c) above.
