Eligibility


- I. Candidates must have qualified UG & PG Degree from a recognized university.
- II. Bachelors' degree in Agriculture with at least 6.5 OCGA out of 10.00-Point scale or equivalent (Trimester/Semester System or at least 55% marks (Traditional System).
- III. Master's Degree in concern/relevant/ allied subject with the minimum requirements of a good academic record with at least 6.5 OCGA out of 10.00-point scale or equivalent degree from an accredited foreign university/Indian university.
- IV. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC/ICAR or CSIR or a similar test accredited by the UGC, like SLET/SET. The candidates who have not passed NET, SLET or SET but have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil/Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET.
- V. A minimum score as stipulated in the Academic Performance Indicator (API) based Performance Based Appraisal System (PBAS) developed by JNKVV in the light of UGC regulations.

Desirable

- I. Familiarity with latest advances in Agricultural developments.
- II. Knowledge of computer application.

Note:

- I. The requirement regarding minimum percentage of marks is relaxed up to 5% for reserve categories candidates as per rules of Govt. of M.P.
- II. The minimum age must be 21 years.

The Vishwa Vidyalaya in its 235th Board meeting held on 17.07.2023, has approved the following guidelines for empanelment of eligible persons/ retired teachers as guest faculty for teaching on honorarium basis :-

1. The applicant should possess qualifications as prescribed by I.C.A.R./ U.G.C. from time to time.
2. The Dean of the College is empowered to invite application/ biodata of qualified candidates through advertisement and constitute the college level committee to scrutinize the applications and make panel of fresh candidates/ Retired Teachers for teaching on honorarium basis.
3. In the event of non-availability of fresh candidate, retired teachers (not more than 70 years of age) may be considered in the panel.
4. Candidates on regular roll of pay in the Govt. Institutions or institutions aided by the Govt. of M.P. / India/ Private Institutions/ Others will not be considered. (undertaking by candidate is required).
5. The honorarium to the persons engaged will be drawn from the Contingent Head.
6. The honorarium to the persons engaged should be Rs. 1600/- per day which should not exceed to Rs. 35000/- (Rupees Thirty Five Thousand) only per month.
7. In case of any dispute, the decision of Hon'ble Vice – Chancellor, J.N.K.V.V., Jabalpur shall be final and will be binding to all parties.
8. The detail of persons engaged on honorarium basis should be provided every month by the Dean to the Dean of respective Faculty.
9. It is a purely a temporary & need based arrangement and may be withdrawn at any time.
10. The reservation policy is to be followed in the process for engaging these Guest faculties. In case eligible young candidates are not found for a subject, then only the retired faculty are to be considered for the said assignments.

All previous guidelines/ amendments in this regard hereby stands superceded.

मि. सं. 9-1/2010(पीएस/मिस.) भाग खण्ड II.—विश्वविद्यालय अनुदान आयोग अधिनियम, 1956 (1956 का 3) की धारा 14 के साथ पठित धारा 26 की उप-धारा (1) के खंड (ड) और (छ) के तहत प्रदत्त शक्तियों का प्रयोग करते हुए, विश्वविद्यालय अनुदान आयोग एतद्वारा विश्वविद्यालय अनुदान आयोग (विश्वविद्यालयों और महाविद्यालयों में शिक्षकों और अन्य शैक्षिक कर्मचारियों की नियुक्ति हेतु न्यूनतम अर्हता तथा उच्चतर शिक्षा में मानकों के रखरखाव हेतु अन्य उपाय संबंधी) विनियम, 2018 में निम्नलिखित संशोधन करता है, नामतः:-

- लघु शीर्षक एवं प्रवर्तन:- (1) इन विनियमों को विश्वविद्यालय अनुदान आयोग (विश्वविद्यालयों और महाविद्यालयों में शिक्षकों और अन्य शैक्षिक कर्मचारियों की नियुक्ति हेतु न्यूनतम अर्हता तथा उच्चतर शिक्षा में मानकों के रखरखाव हेतु अन्य उपाय संबंधी) (द्वितीय संशोधन) विनियम, 2023 कहा जा सकता है। (2) यह सभी नियमन दिनों 01 जुलाई, 2023 से लागू व प्रभावी होंगे।
- विश्वविद्यालय अनुदान आयोग (विश्वविद्यालयों और महाविद्यालयों में शिक्षकों और अन्य शैक्षिक कर्मचारियों की नियुक्ति हेतु न्यूनतम अर्हता तथा उच्चतर शिक्षा में मानकों के रखरखाव हेतु अन्य उपाय संबंधी) विनियम, 2018 में विनियम 3, के उप-विनियम 3.10, में निम्नलिखित उप-विनियम को प्रतिस्थापित किया जाएगा, नामतः:-

3.10 "सभी उच्चतर शिक्षण संस्थानों में सहायक आचार्य के पद पर सीधी भर्ती के लिए नेट/सेट /स्लेट न्यूनतम माना होगा।

No. F. 9-1/2010(PS/MISC)Pt. Vol. II. In exercise of the powers conferred under clause (c) and (g) of sub-section (1) of section 26 read with section 14 of the University Grants Commission Act, 1956 (3 of 1956), the University Grants Commission hereby makes the following amendment in the University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018, namely:-

1. **Short title and commencement.**-(1) These regulations may be called the **University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) (2nd Amendment) Regulations, 2023.**

(2) They shall come into force with effect from 1st July, 2023.

2. In the University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018, in regulation 3, for sub-regulation 3.10, the following sub-regulation shall be substituted, namely:-

3.10 "NET/SET/SLET shall be the minimum criteria for the direct recruitment to the post of Assistant Professor for all Higher Education Institutions."

As a consequence, in regulation 3, for sub-regulation 3.10, of the University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) (1st Amendment) Regulations, 2021 stands deleted.
