Guidelines for Life Time Achievement Award

Genesis

The University has established Life Time Achievement Award in its 154th meeting of Administrative Council held on 30.9.2015 to honour two nominated/selected living Premium, Emeritus Members on the Foundation Day i.e., October 1, per year in recognition of significant and enduring contribution.

Objective

To identify and recognize two members of the University every year who have made significant contributions in the field of research, teaching or extension profession for improvement in agriculture.

Guidelines

The Guidelines proposed for nomination and selection of candidate for Life Time Achievement Award is

Eligibility

- The nominated person shall be the ex-faculty member of the University.
- The nominated ex-faculty member has been superannuated from the services of the University.
- The nominated ex-faculty member must be alive.

Nomination

- Dean of the College/ In-charge of ZARS/RARS/Directorate/ University Professor and Head may submit the nomination of one person for onward transmission.
- All the nominations shall be routed through University Professor and Head of the Department in which the nominated person was originated.
- A page of Vita depicting contribution by the nominated person recognized at international, national, the State and the University level for teaching research or/ and extension; other awards and honours received by the nominated person to select for Life Time Achievements Award are to be provided alongwith given proforma (Enclosure 1), biodata and citation (Enclosure 2).

Deadline for submission of nomination

- Nomination is to reach in the Office of the Dean Faculty of Agriculture, JNKVV, Jabalpur on or before 13 September with an appropriate forwarding covering letter from Professor and Head.

Scrutiny of the proposals

- A committee of the following members will scrutinize the nominations to propose three names on their comparative merits for approval to the Hon'ble Vice Chancellor, JNKVV, Jabalpur through the Registrar

The Award

A short biography will be read, announcing the name of the recipient at the function of Foundation Day in October. A Citation, Memento, *Shal* and *Shree phal* will be presented in honour.

This is an important award, but is necessarily subjective. It should not be viewed to be in any way competitive.

Travelling allowances

- It will be provided by the University i.e., fair of AC II Class of shortest distance from the permanent residential address. The nominated person will be declared as the University Guest for local hospitality.
