Eligibility criteria, for the Post of Dean (Agriculture/ Horticulture)

1. Essential educational qualifications

- (i) Bachelor degree with at least 6.0 OCGA out of 10-point scale or equivalent in other scales (Trimester/Semester/system) or at least 50% marks (Traditional system);.
- (ii) Master's degree in relevant subject with at least 6.5 OCGA out of 10-point scale or equivalent in other scales (Trimester/Semester/ system) or at least 55% marks (Traditional system) or an equivalent degree from an accredited foreign university / Indian university.
- (iii) Doctoral degree in the relevant subject in any branch of Agriculture/ Horticulture or related field.
- (iv) Minimum 15-year experience of Teaching/ Research /Extension in the concerned discipline of the relevant faculty, out of which 10 years should be in Agricultural University/ICAR system and at least 5 years should be in the rank of Professor, or equivalent (UGC AL-14 or pre revised PB 4 AGP Rs.37400-67000+ AGP10000/-) as working experience.
- (v) Outstanding contribution in teaching / research / extension as evidence by published work with minimum 20 research/policy papers in Professional National / International peer reviewed or NAAS/UGC listed journals.
- (vi) A minimum score as prescribed in score card.

Desirable:-

- Administrative experience on a responsible position in an Agricultural University / College / Institute.
- Adequate experience of teaching/research / extension and guiding post-graduate students.

Other conditions:-

- a) The maximum age limit for the applicant for appointment shall be 62 years be reckoned as on last date for submission of application. Candidature of the applicant retired from the Government / Quasi Government / Private Service shall not be considered.
- b) No age bar for the working candidates of JNKVV, Jabalpur.
- c) The age of superannuation on the post shall be as prescribed by the Government of M.P.
- d) The requirement of minimum percentage of marks shall be relaxed up to 5% in case of Scheduled Castes/ Scheduled Tribes / Other Backward Class (non-creamy layer), specially-abled candidates etc. of the state of Madhya Pradesh as per guidelines of the Government of Madhya Pradesh.
