Terms and Conditions:

1. **Only the Manufacturers and their Authorized Dealers** need to submit their tenders. The authorized dealers should furnish a certificate from the manufacturer for their **valid period authorized** dealership. Third party authorization will not be accepted. Submit the **OEM Certificate** or **Manufacturer's Authorization Form** (MAF - if not OEM) in prescribed proforma (*Annexure V*).
2. **No person or firm shall submit more than one Tender for the same item. The bids can be submitted only as single party and consortium of bidders shall not be entertained.**
3. The details of tender document can be downloaded from JNKVV website (www.jnkvv.org) and should be submitted with tender document cost of Rs. 500/- only (**non refundable**) in form of Demand Draft/Pay Order/Banker's Cheque in favor of **Jawaharlal Nehru Krishi Vishwa Vidyalaya Jabalpur payable at Katni**. Payment in terms of firm's cheque will not be accepted.
4. It is mandatory to provide all the relevant information in **Annexure I**.
5. Broad-based specifications of equipment/ items/ systems/ works etc. are given in **Annexure II**. The tenderer should also take note of the remarks, if any, given there in.
6. Tenders must be submitted in sealed cover to the **Senior Scientist & Head, Krishi Vigyan Kendra, Piprodh, Katni M.P. Pin 483442**, by Registered/Speed Post, Courier or delivered personally so as to reach on or before dated 10/03/2026, **5:00pm**.
7. The tender for each item should be sent separately. The main duly sealed envelope should super scribed **TENDER FOR THE ITEM;- Super Seed drill (Super Seeder)** DUE on, **5:00pm**. FOR as mentioned with the specification of the equipment.
8. The Technical and Financial Bids should be kept separately in sealed envelopes with proper labelling. Both the sealed envelopes should superscribed **Technical Bid** and **Financial Bid** for the Item:- **Super Seed drill (Super Seeder)** DUE on, **5:00pm**. FOR as mentioned with the specification of the equipment.
9. Belated tender due to postal or any other delay will be rejected.
10. If offers for more than one item are clubbed together, tender will be rejected.
11. The tenders will be opened on **11/03.2026, 4:00 pm** in the office of undersigned in presence of committee members and authorized representative of the participating firms, with proper authority letters from their principals.
12. Krishi Vigyan Kendra, Katni, JNKVV Jabalpur reserves the right to extend the date of opening of the tenders.

- 13 Date and time of opening of Price Bid will be intimated to the qualified tenders.
Financial Bids (Annexure III) of only technically qualified firms will be opened.
- 14 The rates quoted should be for single complete unit with F.O.R. as mentioned with the specification of the equipment, inclusive of packing and forwarding charges/ loading/ unloading/ handling charges/ freight/ full risk coverage insurance, installation and commissioning charges, custom duty, custom clearing charges of the equipments etc. Any damage during transit, installation and commissioning will be the responsibility of the supplier.
- 15 Prices for the main item and accessories should be given separately.
- 16 Excise duty/ sales tax/ GST/ custom duty and other levies, if any should be shown separately and the total price of each item should be worked out incorporating the same.
- 17 The institute will not provide any custom duty exemption certificate, for the imported instrument on arrival of goods at the port.
- 18 The rate should be quoted in Indian Rupees only.
- 19 The bidder, as authorized representative, has supplied, installed and satisfactorily commissioned and provided after sales service for equipment in India during the last three years.
- 20 The tenderer should furnish the names, contact details including phone numbers and addresses of the users/ govt. department etc. of each of the equipments offered.
- 21 The tender should be accompanied by detailed original printed technical literature (brochure/folder) duly signed and sealed by authorized person with specifications, make and model number of each item and sub-item quoted in the tender. Specifications given in the offer must match to the website and/or authentic printed technical literature or better otherwise the offers shall be rejected. Technical literature of quoted equipment (Tender Item No. must be written on the literature/brochure). A folder showing many instruments without detailed technical specification, or tailor made literature mentioning “yes” or “as per your specifications” for the specifications asked for, will not be considered
- 22 Firm must provide a compliance statement vis-à-vis specifications in a “tabular form” clearly stating the compliance, supported by technical literature with clear reference. This statement must be signed, with the company seal, by the Tenderer for its authenticity and acceptance that any incorrect or ambiguous information found submitted will result in disqualification of the offer.
- 23 Any deviation, variation of non-compliance of the terms and conditions by the tenders shall be considered as a breach of contract and **Krishi Vigyan Kendra Katni, JNKVV Jabalpur**, reserves the right to forfeit the amount of earnest money and/or security deposit in part or in full and take action as per legal arrangement. Tender which does not comply with any of the conditions is liable to rejection.
- 24 Equipments offered should be new and of latest technology. Second hand, rebuilt, refurbished, reassembled or renovated equipments shall not be accepted. An affirmation to this effect will have to be made on the tender form.

25. The tenderers should indicate against each of the item offered period of delivery from the date of placement of order/ date of acceptance.
26. The “ **Senior Scientist & Head, Krishi Vigyan Kendra Katni, JNKVV Jabalpur**” is not bound to accept the lowest quoted rate or any tender and reserves the right to accept or reject any tender in whole or in part without assigning any reasons thereof depending upon the availability of fund.
27. The “**Technical Bid**” in separate envelope mark ‘A’ of each item must be accompanied by **Earnest Money Deposit (EMD) as shown against each item in Annexure-II** in the form of Crossed Bank Draft/Pay Order/ Banker's/ Manager's/TRD of any Nationalized Bank / Scheduled bank made in favour of “ **Jawaharlal Nehru Krishi Vishwa Vidyalaya Jabalpur payable at Katni**”. Without the earnest money in the above form, the offers will be rejected. The EMD in the form of **Firm's Cheque will not be accepted and the offer will be rejected.**
- a. EMD can be exempted only for those bidders who are registered with the SSIC, National Small Industries Corporation (NSIC), MSEs **the items quoted**. The firm should submit, in support, the valid Permanent Enlistment Certificate of SSIC, NSIC for the quoted item only. **Exemption terms:** Micro and Small Enterprises (MSEs) as defined in MSE Procurement Policy issued by Department of Micro, Small and Medium Enterprises (MSME) and Start-ups **registered in Madhya Pradesh** with the National Small Industries Corporation (NSIC), MSEs can be exempted for submission of EMD only if they submit valid Permanent Enlistment Certificate for **EMD exemption** from NSIC, **MSE for the quoted/similar/comparative item and type of business only** as per MP Stores & Purchase Rules 2015 (as amended, 2022).
28. **For bidders who have submitted EMD:** On approval of the tender, in addition to EMD, 3% of the quoted cost summing upto **total 5% of quoted** of the equipment as **Security Deposit** should be deposited in the form of **Demand Draft only** from any nationalized bank/scheduled bank payable to **Jawaharlal Nehru Krishi Vishwa Vidyalaya Jabalpur payable at Katni**. Security deposit will be returned after successful completion of the warranty.
29. **For bidders who have submitted EMD documents for exemption, should deposit 5% of quoted price** of the equipment as **Security Deposit** in the form of **Demand Draft only** from any nationalized bank/scheduled bank payable to “ **Jawaharlal Nehru Krishi Vishwa Vidyalaya Jabalpur payable at Katni**”. Security deposit will be returned after successful completion of the warranty.
30. In the event of withdrawal of tender within period of its validity, entire earnest money and any other deposit made by him along with the tender submitted shall be forfeited.
31. **Payment terms:** The standard terms and conditions of payment is in full only after the successful supply, installation, commissioning, testing, demonstration and training to the satisfaction of JNKVV authorities. Payment to tenderer will be made after deducting taxes and levies at source and for which necessary certificate will be issued.
32. **No advance payment will be made and documents for goods dispatched sent through bank shall not be accepted.**
33. GST invoice should be produced. GST will be paid as per govt rules.
34. Please quote maximum discounted price, as no further negotiations will be made.
35. **Warranty:** The tenderer must provide **Three-years warranty** of the equipment from manufacturer along with guarantee / warranty on manufacturer's letter head with serial

numbers of goods/products supplied for back to back warranty support as per terms and conditions for satisfactory functioning of the equipment/ system in prescribed proforma. The warranty should cover all accessories and local supplied items also. The warranty of all quoted items shall start from the date of commissioning and acceptance (*Annexure IX*)

36. The supplier shall also undertake that **the firm never being blacklisted / banned/declared barred (*Annexure VI*)**. Annexure having delivered dissatisfactory performance by any government /semi-government authority in India for supply of materials / carrying out operations and maintenance work / application development. An undertaking by an authorized signatory of the company need to be submit in this regard as a preliminary undertaking. This Affidavit should be submitted duly notarized on Rs. 500/- non judicial stamp.
37. The manufacturing firm shall have presently **valid ISO Certificate**.
38. The tenderers shall have to give an undertaking that the terms and conditions as mentioned above in this tender are acceptable to the tenderers (*Annexure VII*).
39. The disputes, legal matters, court matters, if any shall be subjected to Jabalpur (MP), India jurisdiction only.
40. The Inspection Committee will examine the equipments for its quality and other technical details mentioned in the specifications. The supplier will have to demonstrate the equipments to the committee at the site and prove its specifications. Laboratory materials for the demonstration including the paper will be arranged by the supplier. The decision taken in the quality test by the Inspection Committee will be final.
41. Supplier should provide the list of items which are covered under consumables. The items not listed in the consumables would be considered as spare parts for the purpose of warranty obligation including replacement/repairs.
42. The competent authority shall not be bound to accept any equipments supplied in excess of the quantity mentioned in supply order(s) and of other than the prescribed specifications. The equipments not conforming to the prescribed specifications will be replaced by the firm within fifteen days after receipt of intimation by him in this behalf.
43. If the firm fails to make supplies within the time specified in the supply order, or to make up the deficiency demanded or to replace the rejected equipments (s) and/or material(s) within the prescribed time, the competent authority may at the cost and risk of the firm purchase said equipments(s) etc. from any other source after giving notice to the firm and recover from the firm any extra cost incurred in making such purchases above the contracted price or deduct the same from any sum payable to the firm or from his security and tender deposits.
44. If the firm fails to remove the rejected equipments(s) etc. the competent authority shall return them at the firm's own cost and risk to his last known address and deduct the expenses incurred thereon from any of the sums payable to the firm or from his security and tender deposits. The competent authority shall not be liable for any deficiency in or damage to the rejected equipments(s) occasioned or occurring while they remain in or under his possession or control or in transit.
45. The tender should have a **validity of 6 months** from date of opening of technical bid. The rate once approved by the Committee shall not be increased for any reason or under any circumstances such as variation of exchange rates or increase in cost of product or increase in transportation etc. Supplier will be bound to supply on the same rates as quoted in the tender. No claim will be entertained for revision to a higher quantity slab, higher production/clearance slab of excise levy although payable by the manufacturer. The Dean, College of Agriculture, Jabalpur may accept revision in price, only in the event of any revision to the basic rate of excise duty, as applicable on the date of agreement, effected by the Govt. of India. A certificate regarding deposit of enhanced excise levy shall have to be furnished by the manufacturer/supplier.

46. On approval of the tender, the supplier should make a notarized agreement on non-judicial stamp paper of Rs. 1000/- stating that the aforesaid "Terms and Conditions" are agreeable to the tenderer. This should be signed and stamped in the presence of two witnesses and purchaser (*Annexure VIII*).
47. **Amendment to the Bid Document:** At any time, prior to the last time and date for receipt of bids, JNKVV, may, for any reason, whether at its own initiative, modify the Bid Document by an amendment. The amendment will be notified in the website www.jnkvv.org, which will be binding on all bidders. In order to provide Bidders reasonable time in which to take the amendment into account in preparing their bids, JNKVV may, at its discretion, extend the last date for the receipt of Bids. **Bidders are advised to visit website www.jnkvv.org at least 3 days prior to closing date of submission of tender for any corrigendum / addendum/amendment.**
48. **Tender** should contain the following documents:

Tender Deposit for the present tender is not acceptable and the Tender shall be deemed to be without valid deposit.

- iv. It is submitted without list of users and technical literature of the offered equipments;
- v. Assurance letter to supply the spare parts and service engineer
- vi. The tenderer has failed to put in his signatures in all the places provided for the purpose in this TenderForm;
- vii. The tenderer has imposed any other conditions beyond those contained in this tenderform;
- viii. The tenderer has made any additions or alterations in the contents of any of these pages of the TenderForm
- ix. The rates quoted are not free from erasures, corrections, overwriting or overtyping;
